Students are responsible for reviewing the financial aid calendar and deadlines. Due to federal, state and institutional regulations, if the required paperwork is not submitted by the posted deadlines, students will be ineligible to receive assistance and responsible for any outstanding bill for that term.

2	First financial aid disbursement to students' account for spring 2017.
4	First refunds for students with aid exceeding university charges for spring 2017.
9	Classes begin for spring 2016 semester.
22	Last day to complete late registration or drop a class and receive 100% cancellation of charges for fall semester.
March	
15	Last day to submit Satisfactory Academic Progress Appeal for spring 2017.
April	
3-7	Financial Aid Awards for the summer 2017 semester begin to be made available online.
14	Last day to submit outstanding documents for the spring 2017 semester.
21	Last day to accept financial aid awards and sign promissory notes for spring 2017.
May	
5	Spring 2017 semester ends.
12	Annual Satisfactory Academic Progress (SAP) review. Students notified of financial aid eligibility for summer 2017, fall 2017 and spring 2018 terms.
15	Classes begin for 4-week and 12-week summer sessions.
16	First financial aid disbursement to students' account for summer 2017 semester. First refunds for students with financial aid exceeding charges for the summer 2017.
17	Last day to complete late registration or drop a class and receive 100% cancellation for the 4-week summer semester.
18	2017-2018 Financial Aid Awards begin to become available for continuing students.
26	Last day to accept Federal Loans for the 4-week summer 2017 semester session.
June	
2	Last day to submit documents for 4-week summer session.
9	4-week summer instruction session ends.
12	Classes begin for 8-week summer session.
16	Last day to complete late registration or drop a class and receive 100% cancellation of semester charges for 8-week summer session.
28	Summer 2017 bill payment due date.
29	Last day to submit Campus Care (www.campuscare.uic.edu) fee waiver for summer 2017.
July	
1	Last day to submit 2017-2018 Health Professions Verification Worksheet for College of Dentistry and College of Pharmacy students.
21	Recommended date to accept financial aid awards and complete requirements, such as promissory notes and loan counseling, for the fall 2017 term.
28	Last day to submit financial aid documents for 8-week summer session.

August	
1	First assessment for fall 2017 tuition and fees.
5	8-week summer session ends.
18	First financial aid disbursement to students accounts for fall 2017 semester.
21	First refunds for students with financial aid exceeding university charges for the fall 2017 semester.
28	Classes begin for fall 2017 semester.
September	
8	Last day to complete late registration or drop a class and receive 100% cancellation of semester charges for fall 2017 semester.
October	
1	2018-2019 FAFSA available - file as soon as possible.
15	Last day to submit Satisfactory Academic Progress Appeal for fall 2017 semester.
December	
1	Priority deadline for 2018/2019 FAFSA filing. Last day to accept financial aid awards and sign promissory notes for the fall 2017 semester.
15	Fall 2017 semester ends.
